Annex No. 3 - Regulations for nomination by the Buyer

In order to enable MFGK to deliver on the gas day the natural gas capacity required to supply the Buyers, it must have the appropriate amount of capacity and natural gas quantity.

In the nomination process, MFGK shall act towards system operators according to the Grid Code section on describing the General rules of Nomination.

In order to enable MFGK as system user to fulfil its obligation specified in the referenced section, Buyer shall comply with the following provisions. Failing this, MFGK cannot guarantee contractual performance.

Nomination rules:

Buyer shall commit to submit to MFGK consumption nomination with its daily consumption forecast data, which shall be confirmed by MFGK to the Buyer.

Buyer shall submit a daily nomination on MFGK's IT platform for each delivery point. The daily nomination can be based on day or hour. In case of day based nominations, the quantity shall be specified in kWh/day as per the Grid Code, while hourly nominations shall be provided in kWh/h.

Buyer shall submit its consumption nomination on MFGK's web-based nomination surface, accessible on the following web address:

Entering the platform by providing the user name and the password, Buyers can submit their nominations by filling in the table generated according to the contractual parameters.

In the event that MFGK's web nomination platform is not accessible or does not function, Buyers can submit their nominations to MFGK electronically (to the email address: nominalas@mfgk.hu).

MFGK confirms nominations also on the IT platform – or by email if the IT platform is disfunctioning.

1. Rules of procedure for daily consumption nominations

Buyer shall submit to MFGK the natural gas quantities requested for the following gas day per gas delivery station until 12:00 on the calendar day preceding the gas day. MFGK confirms to the Buyer the acceptance of the nomination or the valid nomination until 14:00 hours on the day of nomination. MFGK shall be entitled to reduce for the following gas day the quantity requested by the Buyer insofar as:

- Buyer's request exceeds the peak capacity applicable for the relevant day, or
- in case of breakdown, restriction, maintenance or Force Majeure.

2. Rules of procedure for modifying daily consumption nominations

Buyers can modify their consumption nomination until 20:00 hours on the calendar day preceding the gas day. MFGK confirms the valid nomination or informs the Buyer on the refusal until 22:00 hours on the day of nomination. MFGK may refuse the quantity requested by its buyers in cases specified in Section 1 of this annex.

Where the renewed data supply is not accepted by MFGK, the last confirmed daily data supply shall remain effective.

3. Rules of procedure for modifying consumption nominations within the gas day

Regarding transmission pipeline exit points, Buyers may modify their consumption nominations until 15:00 hours for the period of 18:00-06:00, and until 21:00 hours for the period of 00:00-06:00 on the gas day. The modification of transaction notification shall be specified in the Buyer contracts.

Depending on the available sources and related capacities, MFGK either accepts or refuses the modified nomination.

With regard to the hours affected by the modified nomination, the hourly minimum request shall not fall under the hourly minimum as per the contract concluded with the Buyer, and the hourly maximum shall not exceed the hourly maximum as per the contract concluded with the Buyer.

MFGK shall be entitled to refuse the nomination within the gas day due to operational limitations, with particular regard to the cases below:

- in case of exit point delivery, Buyer fails to submit its nomination within the hourly maximum quantity and capacity limits specified in the contract,
- the inclusion of underground gas storage site is restricted (for example, but not exclusively, during storage site cycle switch) to fulfil new buyer nomination,
- refusal of the re-nomination by the Transmission Company (FGSZ),
- emergency in the Hungarian integrated natural gas system.

In case of acceptance, MFGK confirms the valid nomination until 16:00 or 22:00 hours on the day of nomination, while in case of refusal, the last accepted daily data supply shall remain effective.
